WRAMP Implementation

- Santa Clara Valley Water District Pilot WRAMP
 - District wanted to move away from project-based assessment to a broader watershed-based assessment to support their stewardship mission. Also wanted a set of tools that would fit into larger state proejects/assessments
 - Use ambient assessment via CRAM to produce Ecological Service Indices and use these to assign ecological levels of service to specific streams
 - Watershed profile reports will be produced for all watersheds in their jurisdiction. The profiles support planning, permitting, management actions, etc.
 - CWMW would be interested in getting a lessons learned summary from the District

o Action Item:

CWMW will send a letter to the District's board. Letter will include: Thanks for taking initiative and for sharing report; Support for adoption of Framework, consistent with Council Memo; usefulness to other agencies. Paul Jones will draft letter.

• Symposium

- CWMW will put on a 1 or 2 day symposium/workshop to share experience in WRAMP implementation.
- Will be held in February in Sacramento area
- USEPA can provide funding. This could also be coordinated through the Watershed Academy
- Keynote address by the State Water Board on WRAMP implementation and WRAPP
- Maximum of six presentations for the day after the keynote choose the best examples of integration that solves particular problems at the local levels
 - Developing alternatives analysis using 1-2-3
 - Prioritizing restoration/mitigation planning using 1-2-3
 - Ambient assessment
 - Permit tracking
 - Project performance
 - Policy performance

State Board Wetland and Riparian Area Policy

- Good progress on classification and stream definition.
- Progress on both policy and regulation development in for management review in Fall 2011. DEIR for public review March 2012. Target adoption for end of 2012.
- Each water board will eventually need to amend their basin plans to incorporate the new wetland Policy and to designate specific water bodies using the beneficial uses.

Wetlands Portal

 Lots of functionality added to tracker. Not as much work has been done on eCRAM. Eventually eCRAM functionality will be merged into tracker. Draft CWMW Minutes 15 May 10

 Have CIAP money now to work on eCRAM. L2 committee has provided priority actions.

- Working on changing portal content to look more like other portals.
- There was discussion about the relationship between eCRAM, Tracker, Portal, and Atlas

Action Item:

 Tom and Meredith will investigate whether Sacramento District's sixcounty aquatic resource inventory can be hosted on Tracker.

Status and Trends Program

- The team has agreed to: key technical issues, comprehensive mapping (including uplands), balanced approach to optimizing both status and trends, support other programs, draft classification system, including aquatic support areas.
- Final report targeted for summer 2012.
- Classification work currently being done will support the S&T program as well as WRAPP. Need to have classification discussion once TAT memo comes to CWMW.

L2 Committee Update
