History of the Program

 Established in response to an Executive Order in January, 2007, to provide a thorough analysis of all expenditures from California Bonds allocated through the Natural Resources Agency



Data collection efforts — what is collected, where, and how often

- The database does not collect water quality and environmental monitoring information directly. It does list which funded programs and projects are working on water quality, environmental restoration and water management.
- The database is continually updated as reports from funded projects are posted

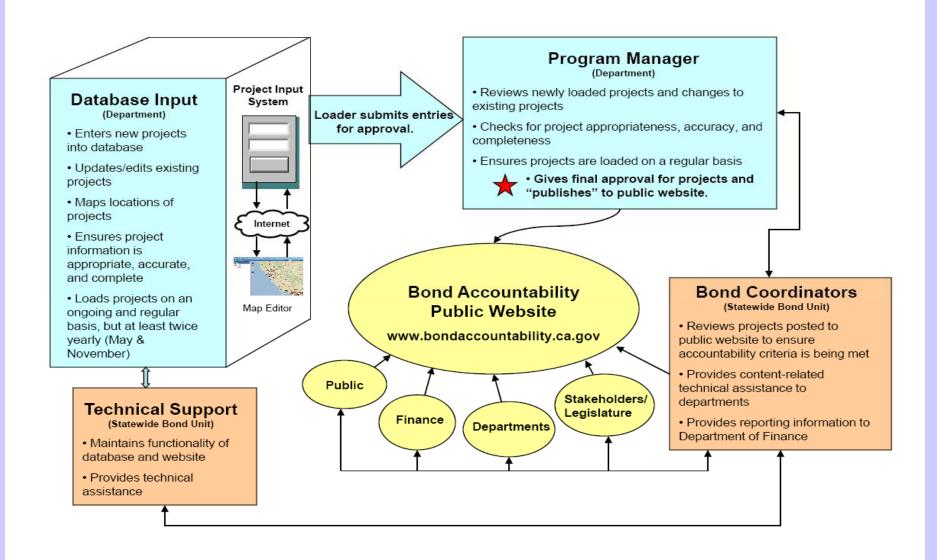

The Purpose of This Site

This web site has been created at the direction of Governor Schwarzenegger to enhance transparency in state government activities, and earn the trust of the voters who approved an historic level of bond funding in November 2006 for the purpose of ensuring a vital infrastructure future for California.

Through bipartisan cooperative action, the Governor and Legislature have initiated the first phase of a comprehensive Strategic Growth Plan to address California's critical infrastructure needs over the next 20 years. California faces over \$500 billion in infrastructure needs to meet the demands of a population expected to increase by 23 percent over the next two decades. In November 2006, the voters approved the first installment of that 20-year vision to rebuild California by authorizing a series of general obligation bonds totaling \$42.7 billion. More

By selecting the "Executive Order" tab, you can access the order signed by the Governor establishing the three-part accountability structure for guiding current and future bond measures.

Selecting the "Strategic Growth Plan" tab will take you to the Governor's proposed plan for California's infrastructure priorities and bond funding over the next decade.

The "Five-Year Infrastructure Plan" tab takes you to the Governor's detailed plan for specific infrastructure expenditures over the next five years.

Finally, web site links on the navigation bar at the left side of this page provide easy access to other sites of related infrastructure and budget information.

Proposition 84 Overview

The Safe Drinking Water, Water Quality and Supply, Flood Control, River and Coastal Protection Bond Act of 2006 (Proposition 84) authorizes \$5.388 billion in general obligation bonds to fund safe drinking water, water quality and supply, flood control, waterway and natural resource protection, water pollution and contamination control, state and local park improvements, public access to natural resources, and water conservation efforts.

The Proposition 84 resources will provide the State matching funds to continue the State Revolving Fund (SRF) Loan Program that was established in 1987 by amendments to the Clean Water Act and is capitalized, in part, by federal funds. The program is administered by the State Water Resources Control Board (State Water Board). The State Water Board issues SRF loans in the amount of \$200 million to \$300 million annually. The Governor's proposed budget includes \$73.2 million in local assistance for this program in 2007-08.

Proposition 84

The SRF Loan Program provides low-interest loan funding for construction of publicly-owned wastewater treatment facilities, local sewers, sewer interceptors, water reclamation facilities; as well as expanded use projects such as implementation of nonpoint source (NPS) projects or programs, development and implementation of estuary Comprehensive Conservation and Management Plans, and stormwater treatment.

The State Water Board adopted Policy Guidelines for the funding process (http://www.swrcb.ca.gov/funding/srf.html). In order to get funding, projects have to meet SRF criteria for four different priorities. Class A projects are those that solve public health problems. Class B projects are those impacting pollution of impaired water bodies. Class C projects are for compliance with requirements and water recycling projects. Class D projects serve as preventative measures against additional water quality degradation for impaired or unimpaired

Eligible projects are placed on a priority list which is updated annually. Projects are funded based on readiness to proceed.

This Program is consistent with Goals 2 and 6 of the State Water Boards' Strategic Plan adopted in November 2001. The Strategic Plan is being updated in 2007; the goals are not expected to change

In-Progress Accountability

Projects selected for funding under the State Revolving Fund Loan Program are required to spend loan funds according to the approved project scope and budget. The State Water Resources Control Board (State Water Board) requires quarterly progress reports for all projects and conducts periodic site visits during construction for each development project. Payment requests must include a certification by the loan recipient that each expense complies with requirements outlined in the loan agreement. Loan recipients must also submit supporting documentation for each expense, with reimbursements approved only for eligible expenses pursuant to program guidelines and contained within the approved project budget. The State Water Board also withholds ten percent of the total loan agreement until the recipient submits a final revenue program for the project and the final revenue program is approved by State Board staff

br>An annual project accounting report is prepared and presented to the DOF. The DOF also performs audits on select projects. The State Water Board maintains a public-accessible website listing all current projects by program, the funding source and timeframe for completion. The State Revolving Fund Loan Program will be included in this current project accounting procedure

Follow-up Accountability

All projects funded via the State Revolving Fund Loan Program receive a final project inspection conducted by the State Water Resources Control Board (State Water Board) during the project's first year of operation. The purpose of the final project inspection is to ensure the project was constructed according to program guidelines and the terms of the loan agreement and that the project is functioning as designed. Loan recipients are required to certify that their projects are meeting the original objectives of the project and submit a report substantiating their certification. All loan recipients must comply with all current laws and regulations that apply to the project and submit documents summarizing total project costs and all additional funding sources

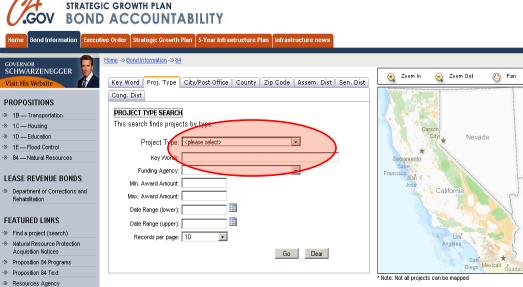

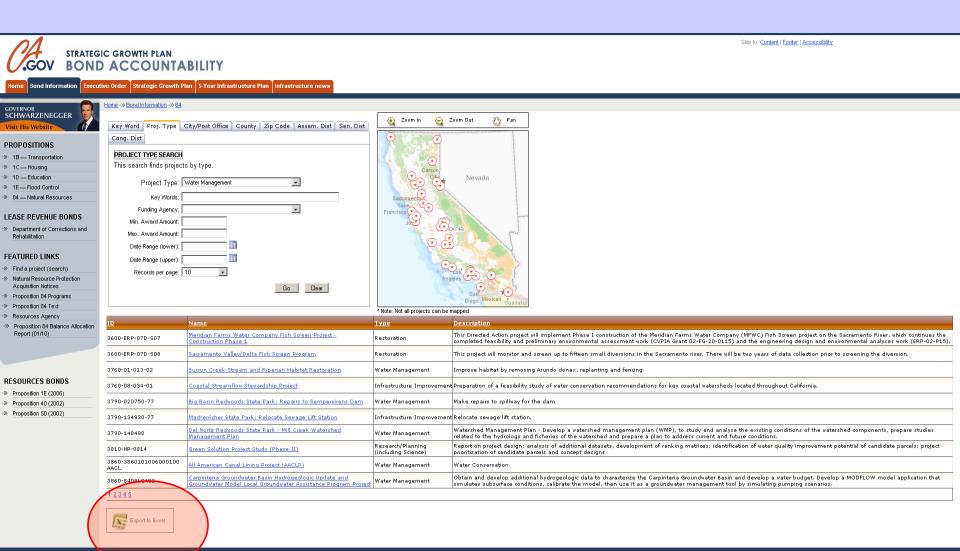
