Notes:	<p>2.1- <i>CA WQMC</i>: The last meeting was held in Costa Mesa, CA. Kris briefly went over the meeting agenda and the topics discussed (see Council <a href="#">meeting notes</a> from August 18).</p> <p>2.2- <i>CA Wetland Monitoring Workgroup</i>: The Wetland Monitoring Workgroup (CWMW) has previously searched for an agency to house their toolsets (e.g., EcoAtlas), as it would help ensure their long-term sustainability. The workgroup has recently worked to develop a business plan, which identifies other options for funding these efforts, among other goals. The business plan was presented at the August 18 Monitoring Council meeting, and the Council members were generally supportive of the workgroup exploring other funding options. The Council members asked the CWMW to return at an upcoming meeting with more details regarding their approach and funding strategies. Kris highlighted that the CEMW would be</p>	

	<p>able to learn from the CWMW's efforts, as the CEMW has experienced similar challenges regarding the long term funding for the Estuaries Portal.</p> <p>2.3- <i>Healthy Streams Partnership</i>: No meetings since September 2016 (no update).</p> <p>2.4- <i>Data Management Workgroup</i>: Tony Hale provided a brief update on the efforts of the workgroup and the details from the last meeting (see July 19 <a href="#">meeting notes</a>).</p> <p>2.5- <i>BOG workgroup for "Is it safe to eat fish?"</i>: There have been updates to the Safe to Eat portal on usability issues and user friendliness since their last meeting in April 2017.</p> <p>2.6- <i>Safe to Swim Workgroup</i>: Not an active workgroup (no update)</p> <p>2.7- <i>Ocean/Rocky Intertidal Workgroup</i>: On hold – Kris suggested removing from next meeting update.</p> <p>2.8- <i>CCHAB Workgroup</i>: Kris Jones provided a brief overview of the CCHAB's July 27 meeting (see meeting <a href="#">notes</a>).</p> <p>2.9- <i>Sacramento River Watershed Program</i>: Portal moving forward on data collection (management and visualization).</p> <p>2.10- <i>Bay Delta Live</i>: No update</p>

<b>Item</b>	<b>3</b>	Approx. Time
Title of Topic:	<b>Data Readiness Assessments</b>	60 min
Purpose:	Kris Jones and Tony Hale will introduce the topic of 'Data Readiness Assessments' and propose using this approach for strategic outreach with key partners—e.g., to identify those partners that are more ready to share their data via the Estuaries Portal.	
Desired Outcome:	Information exchange. Seeking CEMW approval regarding this approach as a potential outreach strategy with key partners.

Notes:	Kris Jones introduced the item, indicating that a group met back in July to discuss CEMW strategic planning. The group sought to try and identify opportunities for collaboration between the Interagency Ecological Program (IEP) and the CEMW. The topic of supporting the IEP and their Data Utilization Workgroup (DUWG) was an opportunity that came from those discussions—specifically using readiness assessments to assess how ready IEP programs are for sharing their data. Kris added that this could be an opportunity to think strategically for the CEMW's outreach, seeking out those groups that are more ready to share their data and carrying out targeted outreach regarding whether those groups would want to partner with the CEMW to make their data available via the Estuaries Portal. In addition, for those groups that are less ready to share their data, the workgroup could identify any potential obstacles, and help provide support (e.g., via the Council's Data Management Workgroup). Tony then <a href="#">presented</a> on data readiness	

	assessments to educate the group on the topic. One idea that came up was to potentially use a survey to assess program readiness, followed by interviews for clarification. The workgroup agreed that this approach was worth supporting, once it has been approved by the IEP Lead Scientist and the IEP Science Management Team (SMT).
